Official petitions must be completed in full compliance with the election rules as outlined in the rules and instructions for the completion of the official petition. They must include each signer's signature, printed name, the last four digits of the signer's member number, and the signer's complete address and telephone number.

Members aged 18 and older are eligible for election if specific requirements under the Texas Finance Code and Regulations of the Texas Credit Union Commission are met. Official petitions must be accompanied by a signed statement from the nominee that he or she is agreeable to the nomination and must include a brief statement of qualifications and biographical data. Elected officials are legally responsible for the Credit Union's fiscal integrity and compliance with State and Federal laws.

Official petitions must be filed at the STAR Financial Credit Union office, located at 10429 Leopard Street, Corpus Christi, TX 78410, before 10:00 a.m. on March 7th, 2024. Remember, no nominations will be accepted from the floor. If there's only one nominee for each position, they will be deemed elected by general consent or acclamation. However, if there is more than one nominee, voting will be conducted at the Annual Meeting where the power of the plurality vote will determine who takes the helm. Let your voice be heard in shaping the future of our Credit Union!
